## 'Heroism': Groups urge support for veterans

WAKE FOREST — At a Veterans Day ceremony Monday that was a mixture of somber and celebratory, local civic groups honored the sacrifice of America's uniformed service members.

Dozens of veterans, their family members and local residents attended the ceremony, organized by the Walter E. Cole American Legion Post 187. It featured prayers, moments of silence and speakers who recognized the service of military members from the past 243 years.

"Most Americans profess to truly love our veterans, especially at gatherings like this on Veterans Day and Memorial Day," said Mark Dwyer, commander of Post 187. "While their feelings are usually sincere, it is important to remember that veterans are defending us 365 days a year. The heroism that has been

demonstrated time and again by veterans from the American Revolution to the global war on terrorism is sometimes unnoticed by those who enjoy the security their sacrifice has

provided."

Later in the ceremony, the audience observed two minutes of silence while Dwyer and Wake Forest Mayor Vivian

Jones placed a wreath to remember veterans who died in the line of duty. Ron Anderson played taps during that portion of the ceremony.

Other local veteran civic groups participated at the ceremony, which was held at

## Wake Forest needs more downtown parking. But where?

WAKE FOREST — An assessment of the town's downtown parking availability found more than 200 new parking spaces may be needed as more businesses and apartments come to the area.

Wake Forest leaders said last week they are interested in finding a way to add more parking downtown and acknowledged that doing so comes at a cost, as the town would likely need to buy land to make public parking available.

What wasn't clear is where that parking would be.

"I think we should certainly include parking, a parking facility, along with the SunTrust," said Mayor Vivian Jones at the Board of Commissioner's Nov. 7 work meeting. Jones was referring to the former SunTrust building on South White Street, which the town bought last year in order to control the development that happens on the site.

"We own that land already" Jones said. "That means we

## Town's top planner looks back on 32-year government career

WAKE FOREST — When Chip Russell joined the town's payrolls in 1987 — well, there was some planning to do.

As the new planning director, Russell, 28 then, was in charge of scrutinizing new development at a time when about 5,000 people lived in Wake Forest. Wakefield hadn't been built yet, and neither had the N.C. Highway 98 Bypass. The town was still recovering from when Wake Forest College packed up and moved to Winston-Salem.

"But things were starting to happen in Wake Forest when I came and I've been busy ever since, 32 years later," Russell said.

On Dec. 20, Russell will retire from town government. The 60-year-old already cleared out his office (he filled five roll-out carts with old papers and items to toss out) and has already started thinking about the new free time he'll have (to fish, golf and finish some projects around the house).

But Russell is also leaving behind his legacy at the helm of a planning department that oversaw explosive growth over the last three decades.

"Chip has been a guiding force in shaping Wake

Forest," Town Manager Kip Padgett said. "From shopping centers to the Heritage and Traditions development, Chip has guided the town and advised the board on planning matters that have positioned Wake Forest to be the community it is today. He has done this while helping to maintain the small-town charm so many admire."

After graduating from Eastern Carolina University's city planning program, Russell landed a job as a planner with the town of Clinton, the seat of Sampson

County. Compared to Wake County, where he grew up, Sampson was a little slower, and when the job at Wake Forest came up, he decided to apply.

"The folks here wanted change, they wanted growth, they wanted opportunities," Russell said. "Fortunately for us the development community and folks wanted to move here, folks wanted to build here. The challenge was just making sure that we made the right decisions and encourage

## Wendell board OKs larger store signs, new permit process

WENDELL — Officials Tuesday approved changes to the town's ordinances that allow bigger signs outside larger businesses and streamlines the process developers must follow when seeking special permits.

Also at Tuesday's regular meeting, the Wendell Board of Commissioners granted a permit to a planned downtown bar and nightclub.

The new sign allowance affects any business at a building larger than 25,000 square feet. The change allows up to 10 percent of the front of a building to be covered by a sign and caps signs at 200 square feet.

The previous rules, which are still in effect for buildings less than 25,000 square feet, allowed no more than a 100-square-foot sign.

The town's planning director, David Bergmark, told commissioners that change will address requests from larger commercial developments coming to the town, particularly in the Wendell Falls area of town.

"What are current ordinances don't address well is some of these larger commercial developments. We're start-

the Wake Forest Veterans' Memorial at 11 a.m. Among those groups were the Daughters of the American Revolution, the Veterans of Foreign

Wars and Rolling Thunder.

Debora Godfrey, president of American Legion Auxiliary Unit 187, spoke about the role women soldiers played in each of America's wars.

"I feel that a women's service to her country is quite often overlooked," Godfrey said, adding her own mother served in the Marine Corps but downplayed her role.

"At that time the male veterans organization at home told her her place was in the auxiliary, and being a true Marine, she told them what they could do with their organization," Godfrey added,

drawing laughter.

Lu Ann Spain, president of the local Rolling Thunder chapter, told the crowd to remember the "many who did not come home." At the memorial was an empty table and chair that symbolized the absence of veterans missing in action or who were prisoners of war.

The posting of the national colors was done by the Wake Forest High School JROTC. Post 198's chaplain, Stephen Haffly, led an invocation and benediction.

Toward the end of the ceremony, the crowd recognized all World War II and Korean War veterans in a special tribute. About two dozen Korean War veterans came forward to be recognized.

The event's many speakers stressed the importance of remembering veterans' sacrifices every day.

"The thing most people forget about are the ones who are suffering the most," said William E. Brown, a retired master gunnery sergeant in the Marine Corps. "At a given time there is approximately 40,000 veterans that are homeless. At any given time there are 15,300 that are on the streets or unsheltered living within the community that we somehow seem to forget about. ... Make sure we don't forget them."

## Don't take vets' service, sacrifice for granted

Monday was a fairly nice day, sunny and with a mild temperature. If you didn't have government business, it was easy to miss that Monday was also Veterans Day. The celebration was, let's just say, not widespread.

And that's a pity, because Americans owe the veterans of this country a tremendous amount of support and appreciation. Our military forces have always been the true protectors of our country and the democratic republic we live under. We are free because they have fought and died to keep us free.

In times past, those words meant more than they do now. When Americans fought their major wars — most recently World War I and II, the Korean War and the Vietnam War — the impact of the wars at home was significant. The draft filled in the gaps when enlistees weren't enough, taking young people away from families all across the country and turning them into veterans on the front lines of death and destruction. The "home front" worked around their absences and supported them whenever they could.

When the troops returned home from the world wars, victory achieved, they were greeted — rightly — as heroes. Their sacrifice was still appreciated during the indecisive but bloody Korean War, and the nation found at least some ways — like the GI Bill and the Veterans Administration — to help them in peacetime.

The draft was last used during Vietnam when 27 million young men were eligible and ultimately 2.2 million were drafted. Vietnam cost the lives of 58,000 Americans, immortalized on the Vietnam Wall in Washington. Sadly, the troops did not come home to honor and celebrations. The war was unpopular and too many Americans at home took it out on the survivors who returned. Vietnam vets have had a rough time since then.

In the aftermath of Vietnam, the U.S. dropped the draft and created the "all-volunteer" forces we have today, the various services recruiting and even competing for recruits. The volunteer military forces have served their country well, sacrificing much for their country in the military conflicts we have had since Vietnam, including the invasion of Afghanistan and the two wars against Iraq. The death toll has been lower, thanks to improved equipment and medical advances, but the number of injured soared and the stress of years of war have inflicted a heavy toll on survivors.

Our military veterans face a lot of problems when they return from combat, which is no less horrible than it ever was. The problem is that most Americans don't see it because only a relative few families are affected compared to the days of the draft.

We've learned to say, "Thank you for your service," but our awareness and our gratitude tend to stop there. The VA is overburdened and underfunded, and too often used as a political football. Military families don't get the support they once had, and the suicide rate among veterans is soaring. But the problems now happen out of sight.

I'm sensitive to this because I've lived through it. I was raised in a military family; my father was a career officer in the U.S. Navy who served in both Korea and Vietnam, commanding several ships and gone as many as nine months at a time. By the time he reached the rank of captain, he served several important tours of duty in the Pentagon.

I was never drafted and medically ineligible to enlist, but I tried to serve as a civilian while in high school and college. I spent two summers working for the Army at Fort Belvoir, Virginia, one summer working for the Navy in Coronado, California, and two summers working in the Pentagon in the Southeast Asia branch of the Joint Chiefs of Staff Secretariat. And I knew friends and fathers of friends who were killed in action, leaving us all to grieve.

When I was a sophomore in high school, I dislocated and broke my knee while playing dodgeball in my backyard, requiring an operation, a full leg cast and a month of care in the hospital at Fort Belvoir. I was in a ward with 12 beds, the rest of them filled with young men wounded in battle back in Vietnam, some of them groaning in traction and all of them disabled in pain.

As these young soldiers traded battle stories about how and where they were injured, I was a bit embarrassed to admit, "I got hurt in my backyard." But I saw their suffering and they were heroes to me.

Our modern military depends upon young men and women volunteers, who are well trained and motivated to serve their country, and we ask a lot of them at home and abroad. It's important to them and to us that we never take their service for granted — and that when they need help in return, we as a nation are quick and generous to provide it. That's what Veterans Day meant to me.

## Surprised by a 4,000-year-old recipe

A recipe for lamb stew reads, "Meat is used. You prepare water. You add fine-grained salt, dried barley cakes, onion, Persian shallot, and milk. You crush and add leek and garlic."

And that's it; no quantities and no instructions.

I guess the cooks who used that recipe 4,000 years ago knew what to do. Lamb stew is one of three recipes on cuneiform tablets that are a part of Yale University's Babylonian Collection, and a team of international scholars are work-

ing to recreate this dish and three others.

What amazes me most is a picture of the 4,000-year-old recipe. It looks much better than the recipes I use.

My husband recently scanned a green tomato soup recipe for me to send to someone who had asked for it, and he commented that it had a lot of green spots on it. I don't know why he was surprised; I was cooking green tomatoes. All the recipes I use often wear drips and spills and leaks and sprays from whatever ingredients I am using.

I have always admired those neat cooks who keep their recipes in plastic covers, so they can just wipe away any

spills and spots before they put them away. Even more amazing are those who cook directly from a computer screen. I have to print my recipes out and have them right in front of me, and in the line of fire.

Should future generations look through my recipe file (well, file is a little misleading; pile is more like it), they will have no trouble spotting the favorites because they will be the dirtiest.

Maybe I need someone to read them out loud to me instead of having to read them myself. I wonder if Alexa cooks ...

don't have to buy another piece of land. It looks like it would be the appropriate place to put a parking facility if we are going to build a parking facility."

In response, Lisa Hayes, the town's downtown development director, said a parking garage on that property will likely be dedicated to residential and retail parking for the site's new development. Any developer likely won't be interested in making room for public parking on the site, she said.

"If that is the case, are you interested in adding additional public parking again at additional cost to the town?" Hayes asked the board.

"Well, I think we have to address the parking," Jones answered.

The mayor and commissioners were discussing the results of a parking assessment conducted by Ramey Kemp & Associates in September. The assessment determined that of the 543 downtown parking spaces, up to 307 (about 57 percent) were filled during peak hours on weekdays. Weekend use peaked Saturday evenings with about 45 percent of spaces filled.

During Friday Night on White events, available downtown lots are at 97 percent capacity, and the event only has enough parking due to a partnership between the town and Southeastern Baptist Theological Seminary for use of their private parking lots.

In the coming years, demand for parking downtown will grow, the assessment found. It estimated demand for parking during Friday Night on White could go up by 25 percent. Planned and expected development — including Norse Brewing Company, Smoky Tony's, Powerhouse Row and new hires made a town hall — could require hundreds of new parking spaces while only adding a few dozen.

Nate Bouquin, a traffic associate with Ramey Kemp & Associates, said he recommended the town add 223 parking spaces to keep up with demand.

Hayes told commissioners town officials will be coming up with proposals, will discuss those ideas with small groups and will come back to the board with recommendations.

things to happen in the right places."

Early on, Russell said he had to overcome budget constraints, staffing limits and long hours. He moved into an apartment in Wake Forest three weeks after taking the job, and a handful of "old matriarchs of Wake Forest" took him under his wing to "make sure you got in line and learned how things are done" in Wake Forest, he recalled.

ner will succeed Russell in the Wake Forest planning department, the town has announced. Russell said the community will be in good hands with Tanner and other planning staff as officials look to control traffic and growth in town.

As he enters his last month in town government, Russell admits he'll miss daily interactions with coworkers but

ing to get more interest from these," Bergmark said. "The Wendell Falls Grocery Store is specifically what brought this to the forefront but the SPC Mechanical building could very well have a similar issue. We just don't have many bigger box stores or we haven't had any kind of large, new industrial sites that may need ... a higher signage than we currently allow."

Commissioner David Myrick was absent at Tuesday's meeting. The other four commissioners unanimously approved the change.

The present commissioners were also unanimous in adopting a new process for granting developers special use permits for new developments. The new process requires the developer to submit a reduced site plan of the development — instead of a complete master plan — when asking the commissioners to approve a special use permit.

A full master plan would still need to be approved by the town's

Technical Review Committee, but only if the commissioners approve the zoning and special use permit. The commissioners would also need to approve the plans a second time if there is a significant change between the reduced plan and the master plan.

Bergmark said this makes it easier on developers because an expensive master plan isn't needed if the commissioners aren't going to approve the project in the early stages.

"I think this is a way of getting a plan out in front of us early without the applicant having to invest as much time and money into it," commissioner Jon Lutz said. "I know

those are expensive and this is a chance to either add some critique at that point or ... ensure it's going to be a good use of their time."

Commissioners earlier in the meeting granted Westerlund and Scheerer Hospitality LLC a special permit to operate a bar in their business on North Main Street. The permit was required because the bar, called Farmers &

Merchants, expects the sale of food might make up less than 30 percent of its revenue. Farmers & Merchants will have a full kitchen and plans to offer appetizers and dinner when it opens, and lunch at a later date, according to meeting documents.

State law will require the bar be classified as a "private club" whose customers must be members who pay a nominal an-

nual fee. In other business Tuesday, commissioners:

- Approved a resolution directing the town clerk investigate the annexation of 151 acres off Rolesville Road, Dav-

istown Road and Yancey Drive.

- Heard the towns 2019 audit report from Petway Mills and Pearson PA.

## Cougars down Huskies in shootout to win NAC 6

WAKE FOREST — Both Wake Forest and Heritage football had no trouble scoring in their rivalry showdown last Friday night, but the Cougars got the big win at home 52-26 to win the NAC 6 conference championship.

Wake Forest took a 28-0 lead within the first 20 minutes of the contest. Heritage cut the deficit to 28-14 at halftime to make it an interesting game. However, the Cougars pulled away in the second half, outscoring the Huskies 24-12 to

finish the night as conference champions.

“We had decent field position off turnovers,” Wake Forest head coach Reggie Lucas said. “We finished in the red zone, which is very important. That helped us early in the game.”

Wake Forest quarterback Noah Douglas led the offensive outburst with two touchdown passes, one to Kahlil Watson and the other to D.J. Sellers. The senior also added a 25-yard rushing touchdown.

“I’m proud of how my guys played in the first half,” Douglas said. “I give a lot of credit

to my offensive line.”

With Douglas as the dual-threat quarterback, the Cougars have scored more than 40 points in eight games this year. The transfer from Rolesville High School has excelled on the field with 12 touchdown passes and seven rushing touchdowns so far in his senior season.

“I feel like I’ve grown a lot as a player,” Douglas said. “I’m looking to improve each week after every game.”

Another standout player for Wake Forest was Watson. The

## Rovnak makes history as state champion

WAKE FOREST — Franklin Academy’s Aaron Rovnak won first place in the 1A state championship boys cross country meet at Kernersville last Saturday, becoming the first Patriot to do so in the history of the boys program.

The junior ran a 16:05.97, beating second-place Drew Zink of Lincoln Charter by 25 seconds. He was one of three runners to finish the championship race in under 17 minutes. Last year, Rovnak finished third overall at the 1A state meet with a time of 16:40.98. This time, he emerged victorious.

“It feels great,” Rovnak said. “I couldn’t have done it without my teammates, my previous coaches Coach (Beth) Martin and Coach (Justin) Rhodes. My parents came to most of my meets and helped condition me. Coach (Rob) King really helped me improve by a minute this year. Everybody helped me achieve this goal. I was able to go out and do it because of them.”

Rovnak ran a personal best time of 15:45.84 in the 1A Mideast regional meet a week before and won first place in that as well. He said winning the competitive regional meet helped boost his confidence at the state championship.

“I thought that I was the strongest coming into the race,” Rovnak said. “I knew it was going to be between me and Drew Zink from Lincoln Charter. I was able to beat him by 10 seconds in the regional meet. I knew that I was in the best shape of my life and as long as I didn’t burn myself out in the first mile and ran my race and not think about the cold weather, I knew I could win.”

Franklin Academy head coach Rob King said with confidence that Rovnak is the best runner in the state at the 1A level and the first-place finish at the state championship confirmed that.

“Seeing Aaron win was a great thing for our program,” King said. “I’m very proud to be a part of it. Aaron would turn that first-place trophy in for a team trophy in a heartbeat if he could. That’s the kind of team player he is. He left no doubt that he is the best 1A runner in the state.”

King has known Rovnak since he was in middle school as his physical education teacher. He also coached Rovnak when he played for his

middle school basketball team. He said the student athlete hasn’t changed over the years and that’s what makes him special.

“I’ve known Aaron since middle school and

not much has changed,” King said. “He’s been consistently the same guy. That things that define him now defined him earlier as well. He has missed zero practices

this year. He is dedicated and a leader by example. He always does his best and that doesn’t change throughout the years.”

As a team, Franklin Academy’s boys team finished sixth overall with 184 points. The Patriots finished behind Pamlico County (182 points) and ahead of Lejeune (198 points).

“I think our team has a huge shot to win the state championship next year,” Rovnak said. “I’m going to go for first place again next year, because that’s going to help our team the most. If all of our guys come back healthy and works just as hard, the state championship will be ours.”

Franklin Academy’s girls team broke their streak of three consecutive 1A state championships with an eighth-place finish at the state meet. The Lady Patriots tied with Highland Tech with 226 points, but broke the tie with average run time. Franklin Academy finished behind Pine Lake Preparatory, who scored 216 points. Franklin Academy’s conference rival Research Triangle

The Patriots played conference rival Voyager Academy at home Wednesday night in the third round of the 1A state playoffs, but the results did not reach press deadline.

In other local soccer news, Heritage lost to Hoggard 2-1 in the second round of the 4A state playoffs last Saturday. The Huskies finished the season 16-6-3 overall.

RALEIGH — Wakefield's boys basketball team is coming off its best season since 2011. Now the Wolverines will try to sustain their progress entering the new year.

Wakefield went 24-5 overall last season and won the NAC 6 conference championship. That was their first conference title since 2011, back when they were in the CAP 7 conference.

Wakefield's 2018-19 season ended with a loss to South Central High School in the fourth round of the 4A state playoffs. That's the farthest the Wolverines have made it into the post-season since 2011.

Wakefield also lost a large number of seniors who made heavy contributions to last year's squad. Trae Smith, Elijah Shabazz, Nyeem Smiley, Darrius Everett, Ja'Ques Shields, Kharye Cayne and Jawon Eddie all left big shoes to fill for the new upcomers.

"The biggest lesson to take from last year is competing all the time," Stevens said. "Practice, scrimmages, games, it doesn't matter. We had some times this summer and a couple days of practice so far where we haven't given it our best. Each day is a chance to improve

and get better both individually and as a team and we want our guys to keep that in mind."

Out of all the players coming back for their senior season this year, Wakefield will look to get big numbers out of Vernon Fraley. The 6-foot-4 forward averaged 9.8 points and 6.6 rebounds per game as a starter on varsity last season.

"Vernon Fraley is ready to have a huge season," Stevens said. "He's been a varsity guy for four years now and it shows. His leadership, activity level, confidence and ability on both ends of the floor should stand out. He was sort of in the shadows of Trae and Elijah the past couple years, but has a chance this year to really leave his mark on our program."

Wakefield will also have some new starters this year who will look to prove themselves on the court. Stevens mentioned a couple of players who could make a big splash this season.


"Harper Strickland had a really good summer and is a kid we are very high on," Stevens said. "He has a great offensive skill set, is very active and had a chance to get used to the varsity level at the end of last season during the conference tournament and playoff run. Brenon Rogers had some big moments

for us last year and is our second most experienced player behind Vernon. If we can keep him focused, he could cause a problem for a lot of teams."

With all that being said, Wakefield is currently the favorite to win the NAC 6 conference again this year. Even though they lost plenty of starters from last season, the Wolverines have firmly established a culture of winning that could carry them through this year. Stevens said it's up to the players to keep the legacy of Wakefield basketball alive.

"The goal the players have set for themselves is to sustain," Stevens said. "They don't want the hard work our seniors put in last year to go to waste and don't want the program to have a drop off. Going into my fourth year, I just want us to compete and continue working hard each day and the results will take care of itself. We have some inexperience and youth at the varsity level for the first time in awhile. I hope to see a team that makes huge strides as the season progresses."

Wakefield will play their first game of the season at Enloe on Wednesday at 7 p.m. Their first home game of the year will be against South Granville next Friday at 8 p.m.

# Rams plunder Pirates on senior night

ROLESVILLE — On a Rolesville High "Senior Night" when those honored were superb, its sophomore quarterback shared the limelight during a 49-19 offensive scorching of Corinth Holders.

Rams football (9-2) celebrated its present winningest class in school history while unleashing the firepower of its future. Byrum Brown connected on 10-of-11 passes for 291 yards and four touchdowns as he brought the multidimensional attack back after a two-week losing streak vs. the top teams (No. 1 Wake Forest and runner-up Heritage) in the NAC 6 conference.

Last-term performers Josh Pullen (12 carries, 110 yards, two touchdowns) and Jashaun Patterson (four carries, 67 yards; three receptions, 162 yards, two touchdowns) did their own thing in a big way, as well. The combined efforts resulted in 44 plays generating 563 yards and points on Rolesville's first four possessions.

Pullen dashed in from 24 yards out with 7:40 left in the first quarter to establish a lasting lead. Patterson kept and tallied the two-point conversion for an 8-0 count.

The visiting Pirates benefitted from a 30-yard kickoff return and a pass interference foul on Rolesville to ignite a drive. After seven plays ventured 46 yards,

the possible tying deuce pass fell incomplete. So the Rams maintained an 8-6 edge.

It grew two scrimmage hikes later when Brown hit Patterson on a 75-yard toss. Devin Versteegen's PAT pumped the margin to 15-6 with 2:58 left in the period.

After Corinth Holders punted, Rolesville required just another pair of snaps to further inflate the bulge. A Patterson 50-yard sweep corresponded with a Brown 27-yard strike to freshman Noah Rogers with just 12 seconds remaining in the stanza. Versteegen supplied the PAT for a 22-6 difference.

The Pirates next opportunity concluded with a fake punt failure at the Ram 38. Three cracks at it later, Brown lofted 50 yards to junior Ethan Harris for the score. The two-point conversion missed, but the gulf was 28-6 with 9:07 left before half.

Corinth Holders conducted an 11-play drive as far as the Ram 11 prior to coming up short on fourth-and-18. After getting the ball back by punt, it cashed in a 65-yard hook-and-lateral with 1:09 left till intermission. The deuce failed, leaving it 28-12.

The pesky Pirates (4-7 overall; 0-5 in NAC 6) recovered the ensuing kickoff and applied more late pressure. However, John Burch grabbed an interception to repel the invasion.

Just 1:34 into the third quarter, Brown again hooked up with Patterson on a 62-yard hail. Versteegen built the 35-12 gap.

Brown completed passes of 19, 3, 9 and 10 on the subsequent 75-yard drive which took 10 total plays. Brown (six keeps, 35 yards) bootlegged 11 yards to the 8 yard-line, then handed off to Pullen twice for the finishing totes. Versteegen made it 42-14.

James Cowan partially blocked the next Corinth Holders punt from the end zone, setting his offence up at the enemy 37. On the first hike of the fourth quarter, sophomore Jaedyn Fulton swept over from the 34. Damon Burton posted the PAT for the maximum advantage at 49-12.

The Pirates countered behind its own sophomore signal caller Isaiah Faulkner (16 keeps, 59 yards, one touchdown rushing; 7-of-19 passing, 134 yards, one touchdown, two interceptions). He ran five times for 47 yards, eventually smoking in from the 1 with 5:35 left in the contest. The PAT pasted the final.

"We've been through the first season --- the non-conference schedule. Now we're done with the second season --- the conference," Rolesville head coach Martin Samek said afterward. "From here, we focus on the third season --- the playoffs. Our work is not done. We are not finished yet."

Rolesville finished the regular season undefeated at home at 6-0. The Rams will host the Panther Creek Catamounts tonight in the first round of the 4AA state playoffs at 7:30 p.m.

junior made plays all over the field. He accomplished a rare feat where he scored a receiving touchdown, blocked a field goal, recorded a sack and picked off an interception in the same game.

Watson said he wanted to make up for the time lost after missing the last game due to an ejection against Rolesville two weeks ago.

"I had to ball out for my teammates tonight after coming back from suspension," Watson said. "I had a lot on my shoulders. I just corrected myself and we all played well."

Lucas complimented Watson for his versatility and being an integral part of the team, both offensively and defensively, as well as special teams.

"We know what kind of athlete Kahlil is," Lucas said. "He can make plays in any ball game. You have to have him on the field every week."

Most of Wake Forest's points also came from running the ball. Elijah Hines scored on a 62-yard sprint and a 25-yard run. Chris Moore broke off a 53-yard rushing touchdown. Lucas said the offensive line helped open holes for his players to run through against Heritage.

"We talked about executing our assignments

on the offensive line," Lucas said. "When our offensive linemen pull and run harder, they can make big plays."

Even though Wake Forest held the lead the entire game, Heritage did not give up. The Huskies cut the deficit to 42-26 in the third quarter. However, the Cougars held strong in the fourth, keeping Heritage out of the end zone.

Heritage quarterback Walker Harris threw four touchdown passes, but Wake Forest's defense also intercepted him three times. Chance Smith and Watson picked off a pass and early in the third quarter, and Damien Peacock returned an interception 25 yards for a pick-six touchdown.

"We knew Heritage could strike at any time," Lucas said. "They have a bunch of playmakers over there. Their quarterback, Walker Harris, can throw the ball all over the field every week."

field. We wanted our guys to play all four quarters. We didn't want to beat ourselves up when we gave up those big plays."

During halftime, Wake Forest honored former running back Bryce Love by retiring his jersey. Love was a Heisman Trophy runner-up as a running back at Stanford University. He is now a rookie in the NFL with the Washington Redskins.

"When I became a head coach, there were certain things I wanted to check off my personal list," Lucas said. "One of those things was to get guys in the NFL.

If we got them there, I want to retire their jersey. That's what tonight with Bryce Love was about."

Speaking of Wake Forest running backs, the Cougars will be without their star player Maquel Haywood for the rest of the season. The senior injured his knee earlier in the year and it turned out to be a torn ACL, meaning his high school playing career is over.

Lucas said the players wanted to honor their teammate on senior night by getting the big win for him.

"Maquel has put his heart

into this program," Lucas said. "His parents raised him the right way. He's a professional high school student athlete. For him to tear his ACL again, I know he's devastated. Having him hang in there says a lot about his character."

With their first NAC 6 conference loss of the season, Heritage dropped to 7-4 overall and 4-1 in conference play. The Huskies will still have a decent position to make a 4A state playoff run.

With the NAC 6 conference championship win, Wake Forest finished the regular season 10-1 and

undefeated in conference play at 5-0. Lucas said the players have to get ready for the postseason by doing what they do best: working on the fundamentals.

"We want to heal up and figure out who are opponent is so we can study them," Lucas said. "We have to focus on doing the little things right. We've gotten this far by focusing on the fundamentals of football."

"Our main thing going forward is to execute the plays," Watson said. "We just have to keep running our game until it's perfect."

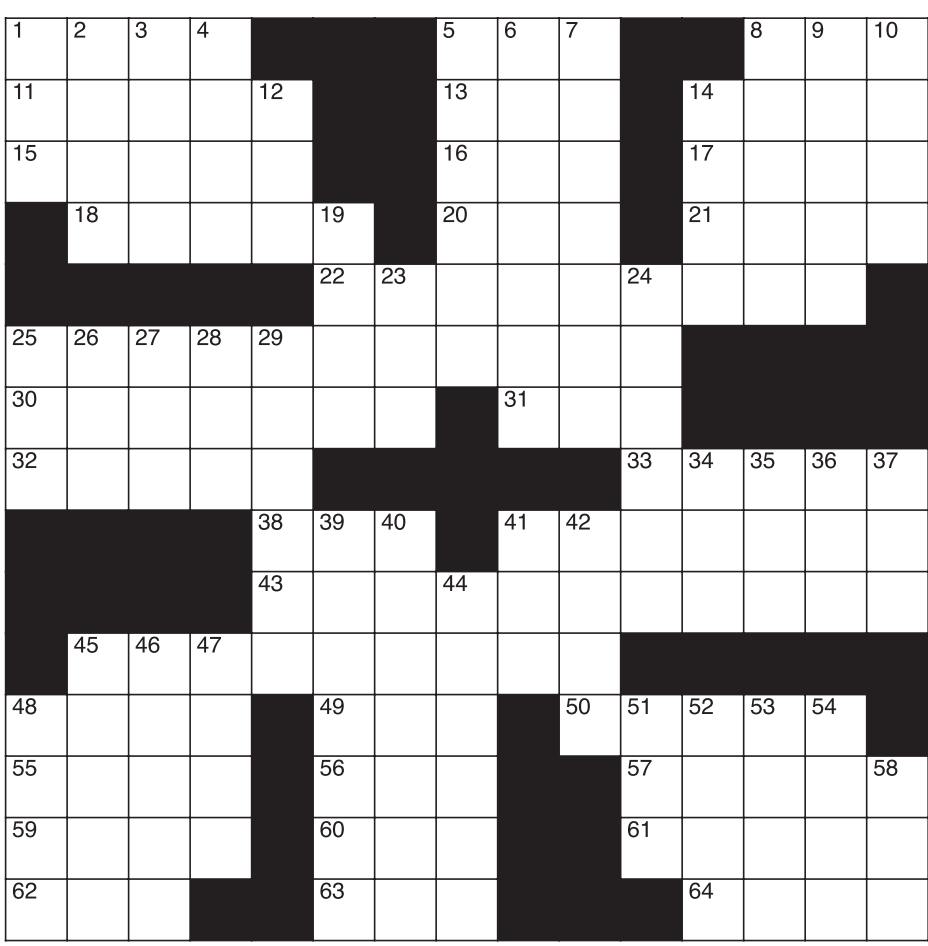

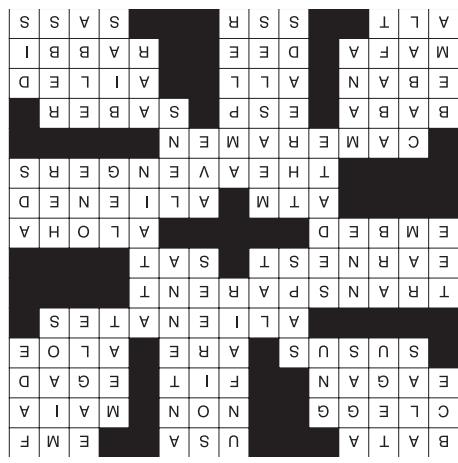

# Recipe inspired by a Disney trip

## Potato soup packed with goodness

My family's trip to Disney World last month was filled with fun rides and attractions, relaxing time by the pool, lots of walking and plenty of food.

In the months leading up to our trip, we did our research on restaurants and snack menus, choosing where we wanted to eat. Because our trip coincided with the annual Epcot Food and Wine Festival, we had even more options.

Our list of foods to try varied from Mickey Mouse waffles at our resort to warm raclette Swiss cheese with baby potatoes, cornichons and baguettes near the Norway pavilion in Epcot.

We dined at wonderful restaurants. My favorites were Chef Art Smith's Homecomin' at Disney Springs, where I ate the most delicious buttermilk-brined fried chicken with mashed potatoes and a cheddar drop biscuit; Via Napoli Ristorante e Pizzeria at Epcot, with a much-anticipated fire-oven pizza and strawberry acqua fresca that I crave every day; and Chef Mickey's, where we arrived for dinner on the monorail and all chose what we wanted from a bountiful buffet. Mickey Mouse

helped me walk up the steps at Chef Mickey's and even blew me a kiss as he walked away. It was so much fun.

We all picked up snacks along the way during our four days at the parks and often shared treats including popcorn, Mickey-shaped pretzels, fancy cream pastries in the French pavilion and strawberry-dusted yeast donut holes. One of my favorite treats was a non-alcoholic drink at The Night Blossom in Animal Kingdom's Pandora area. It's a mix of limeade, apple and pear topped with bobo balls. My granddaughter and I loved it.

At Epcot, we used many snack credits from our Disney Dining Plan to try foods at the festival. We had all looked forward to stopping at the Canada pavilion to sample the wild mushroom beef filet mignon from Le Cellier as well as the Canadian cheddar and bacon soup. The tender steak and creamy soup were among our favorites, hands down. In fact, the filet mignon has probably been the most-talked about food item of our trip.

Once we were back at home, I started thinking about that soup. Honestly, when I was eating it, I thought it was a cheesy potato soup, but, in fact, it was a white cheddar cheese soup with no potatoes. I looked for copycat recipes and found quite a few, including a Disney recipe. But I didn't want to make a cheddar cheese soup; I wanted potato soup.

So, I adapted the recipe, incorporating some elements from other soups I make, and came up with a delicious soup. I did follow the recipe directions to a point, and found it easy, although a little time consuming. But it was worth the effort.

Reggie and I ate the soup Friday night and again as leftovers on Sunday night. I added a little milk and chicken broth to the leftovers so the soup wouldn't be too thick. We loved it both times.

**RECIPE NOTES**

Although I started with a basic recipe, I made a number of changes that are reflected in the recipe. I used 10 slices of

microwave bacon, cut and cooked in the skillet until it got a little crispy and left some bacon drippings in the bottom. Next time I might use a few more slices.

I added around 2 cups of unpeeled, cubed red potatoes to the cheddar soup recipe. Next time, I will use at least 3 cups of potatoes.

I never cook with red onion and almost used sweet onion instead, but I didn't. The red onion does add a nice flavor.

I didn't use Tabasco sauce, which is apparently in the Disney recipe, but we loved the addition of Worcestershire sauce.

Next time I make this recipe, I will warm the milk some — probably to room temperature — before adding it to the soup. It took a long time for the soup to warm after the cold milk was added.

I also covered the skillet while the soup simmered so the veggies would cook.

For this soup, I used a new enameled cast iron braiser from Le Creuset, so the soup didn't stick. Be careful when you make this; stir often and don't turn the heat up too high so it doesn't stick.

### Cheesy Potato Soup with Bacon

I adapted a Disney recipe to create this delicious soup. It's a great way to warm up on a cool day. Eat it with a hearty loaf of bread and fresh fruit.

| 1/2 to 3/4 cup chopped celery  | 4 cups chicken stock (I used a box of low-sodium chicken broth) | 1/2 to 1 teaspoon salt, or to taste |
| 3 cups diced, unpeeled red potato                                    | 4 cups warm milk (warm to room temperature; I used skim milk)   | Ground pepper to taste              |
|  | 1 cup cheddar cheese  | Extra cheese or bacon for garnish   |

Cut bacon in small pieces and add to 4- to 5-quart non-stick pot or Dutch oven over medium-high heat. I used a cast iron enamel braiser. Stir the bacon to brown, around 4-5 minutes. Watch carefully so it doesn't burn.

Add onion, celery and potato to pan and saute until vegetables start to soften, around 5 minutes.

Reduce heat to medium and add flour. Stir constantly for 3-4 minutes until flour covers vegetables.

Stir in chicken broth and bring to boil. Boil for a minute then reduce heat to medium or low. Simmer for 15 minutes, covered; stir occasionally.

Add milk, at room temperature, and let simmer for another 15 minutes, with some of that time covered. Do not boil.

Remove from heat and add cheese, Worcestershire sauce, salt and pepper. Stir until smooth. If soup is too thick, add more milk.

Garnish with cheese and bacon if desired.

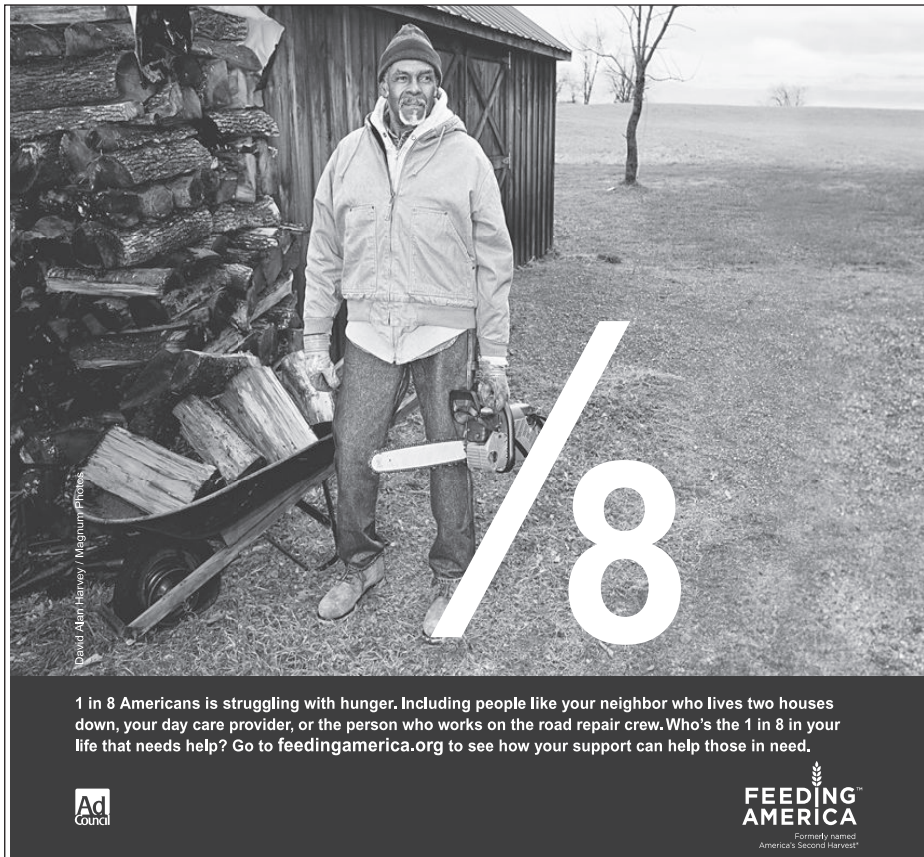
